We will display posters, distribute and "share" information about COVID-19 across our digital channels and at appropriate locations around our club house and venue. Where appropriate, we will identify and address potential language, cultural and disability barriers associated with communicating COVID-19 information to participants, members and other stakeholders.

In conjunction with our state governing body, Little Athletics NSW, we have developed and promoted amongst our members and stakeholders, a range of resources on COVID-19.

# Tell us how you will do this

Members have confirmed acceptance of our COVID saftey plan on registration. Details include the fact that Until December 1 or otherwise advised by public health orders only fully vaccinated competitors/spectators/volunteers 16 or over will be permitted entry to the ground.

Ground entrances will be limited to 3 entry points with COVID marshalls ensuring all attendees sign in and out plus checking vaccination certificates prior to entry.

# **Physical distancing**

Capacity at an outdoor community sporting event must not exceed the lesser of 1 person per 2 square metres of space of the premises in which the activity is conducted, or 1000 persons.

At Girraween Little Athletics we have revised our activities to ensure that our attendance will not exceed 1,000 people or 2 square metres.

The following restrictions will be implemented

- · All persons entering the CV Kelly grounds must scan the Service NSW QR Code. Names of additional people scanning for (athletes / children etc) must also be included.
- $\cdot$  All persons are encouraged to download the Service NSW App.
- Ground entrances will be limited to 3 entry points with COVID marshalls ensuring all attendees sign in and out plus keeping a tally of people at the ground.
- If ground attendance reaches 1,000 people gates will be closed with entry no longer permitted.

# Ensure 1.5m physical distancing where possible, including:

- at points of mixing or queuing
- between seated groups
- between staff / volunteers.

#### Tell us how you will do this

Social distancing is to be exercised at all times. The following ways will be employed to achieve social distancing:

- o Smaller groups of athletes at each event
- o Repositioning of events where possible
- o Using the minimum number of officials / helpers to run events
- o Clear markings on the ground to indicate appropriate spacing (where possible)
- o Regular PA announcements and reminders to parents/spectators
- o No parents/carers will be allowed on the field unless helping/Age Manager at events. (1 parent/carer per athlete will be permitted at field events for Tiny Tots and Under 6 age groups. No strollers or siblings will be allowed on the field at any time).
- o No physical contact such as hugging, handshaking or high fives. Verbal good luck and congratulations are good alternatives.
- o All athletes must bring their own water bottles which must not be shared.
- o All athletes and Age Managers and Helpers are to use hand sanitizer prior to each event

Minimise mingling of participants from different games and timeslots where possible, particularly people aged under 16 who may not yet be fully vaccinated. For mass participation events, consider staggering the starting times for different groups to minimise crowding where possible.

#### Tell us how you will do this

Wherever possible, we will allow time between age groups at each event (particularly field events), to enable one group to leave the event area before the next group arrives, to minimise congestion and contact.

We will communicate with age managers, officials and members to encourage personal equipment and bags be arranged to maintain adequate physical distancing between individuals.

Wherever necessary, we have identified separate entry and exit points to the venue via signage and communicated this to participants and parents/carers.

We will advertise on our website and social media channels that all participants and volunteers attending our Centre competition and training days are required to where face masks whilst indoors. We will make announcements over the PA system throughout our activities reminding participants and volunteers masks must be worn indoors.

We will Inform and educate all participants and volunteers about the relevant government websites that have up to date information on what effects COVID-19 is having in the Community and how wearing masks will lower the chances of contracting COVID-19 resulting in a significantly lower chance of serious ill health.

# Adopt good hand hygiene practices. Have hand sanitiser at key points around the venue.

We will wipe down key spaces, surfaces and objects (such as benchtops, door handles, keys etc regularly).

#### Further we will:

- Promote and provide hand washing guidance to all participants and volunteers (http://www.who.int/gpsc/clean\_hands\_protection/en /);
- Promote regular and thorough hand washing by volunteers and participants;
- Provide sanitising hand rub within the venue and refill regularly;
- Replace/refill soap in toilets regularly;
- Place bins around the venue.

We will provide hand sanitiser within the venue and ensure it is regularly refilled.

We will encourage participants, volunteers, and/or parents/carers to carry personal hand sanitiser to enable good personal hygiene.

## Ensure bathrooms are well stocked with hand soap and paper towels or hand dryers.

Use the NSW Government QR code system to collect an electronic record of the name, contact number and entry time for all staff, volunteers, attendees and contractors.

Note: Organisations are not required to keep proof of vaccination status in their records.

Our Centre will be using the Service NSW QR Code system.

All paper-based registers will be transferred to an electronic spreadsheet by the COVID Safety Officer within 4 hours.

Centre weekly results are recorded in an online Competition Management System. This allows the Competition Administrator to identify which members were in attendance on any given day.

Officials/volunteers are required to sign-on each week for insurance purposes, and this sign-on information will double as an attendance register for the purpose of contract

tracing.

Processes must be in place to ensure that people provide the required contact information, such as by checking phones for the green tick to confirm they have checked in (keeping 1.5m physical distance between staff and patrons). QR codes should be clearly visible and accessible including at entrances to the event.

The Service NSW QR Codes will be visible and available at various entry points throughout the facility where attendees will be requested to utilise QR Codes to check in on entry and out on conclusion of activity.

Volunteers will be placed at entry points ensuring all attendees are checking-in using the Service NSW QR Code.

Social Distancing signs will be placed at intervals of 1.5m along the fence to guide spectators on physical distance requirements

Announcements will be made throughout the activity requesting all participants to ensure they have checked in.

If a person is unable to provide contact details, for example due to age or language barriers, another person may provide contact details on their behalf. If it is not possible for check-in to occur, keep a record of the name, contact number and entry time for all staff, attendees and contractors for a period of at least 28 days. These records must be provided in an electronic format such as a spreadsheet as soon as possible, but within 4 hours, upon request from an authorised officer.

Other types of venues or facilities at the event must complete COVID-19 Safety Plans where applicable. If contact details are captured electronically upon entry to the event on the relevant day, additional collection of contact details via electronic methods may not be required if there is no other public access to the sub-premises. However, additional contact details and time of entry must be captured if the event has sub-premises that are gyms, entertainment facilities, hospitality venues, nightclubs and retail premises.
